On-Street Permit Parking Program

Short-term/temporary permits are valid at designated 10-hour meters or designated off-street locations in the residential area of the University District (see map). Permit holders are exempt from the "no parking 3 a.m. to 5 a.m. restriction." Permit is to be used by the permit holder only and cannot be used or transferred to someone else. The permit is valid at assigned location(s) only and must be displayed from the vehicle's rear view mirror at all times when parked. Failure to display the permit may result in ticketing and/or towing of the vehicle at the registered owner's expense. Permits are subject to availability, are for a maximum of 30 days, and are non-renewable.

Purchasing a Permit

The cost of a 1 - 4 day permit is \$7.50 per day and a 5 - 30 day permit is a flat rate of \$35. Permits are sold from 8 a.m. - 4:30 p.m., Monday through Friday at the Parking Programs Office. The following information is needed to obtain a permit and may be submitted in person at 713 Edgebrook Dr, Champaign; by fax at (217) 403-7061; or by email at parkingcollections@ci.champaign.il.us:


- Completed application

Permits are available on a first-come, first-served basis only. No refunds are given for cancellation of this agreement at any time during the rental period.

On-Street Residential Area Short-Term/Temporary Visitors' Parking





